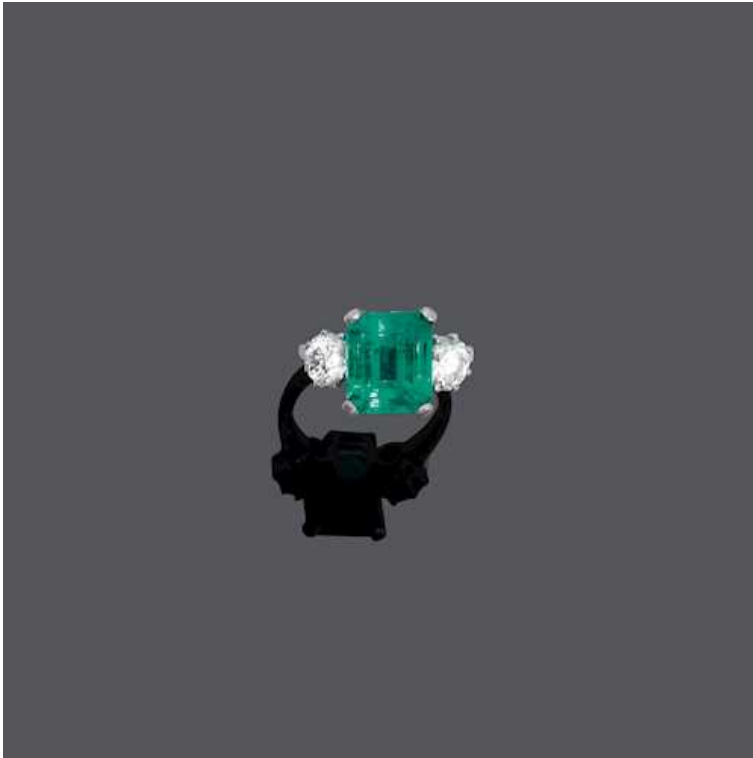

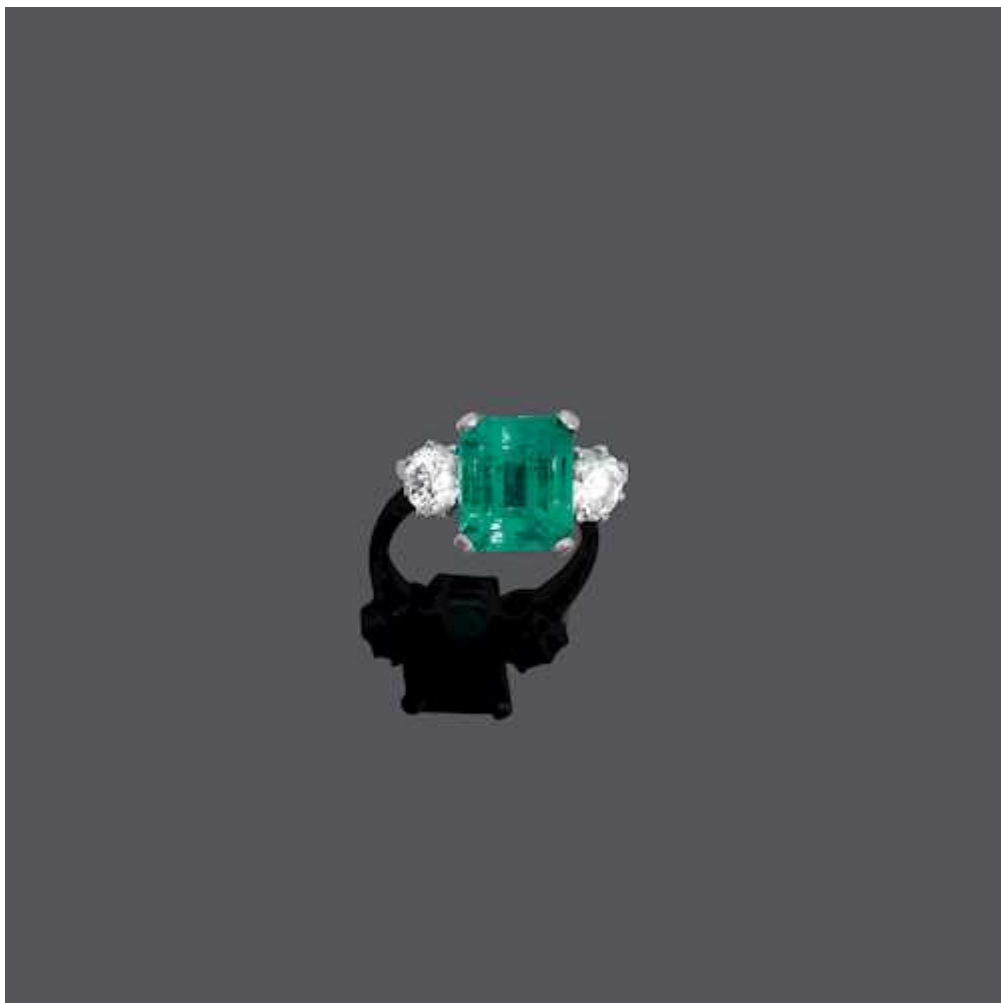
White gold 750, 7g.
