Exceptional Ruby

The natural ruby described in Test Report No. 115272 from the Swiss Gemmological Institute SSEF possesses extraordinary characteristics and merits special mention and appreciation.

The described ruby is set in a ring with small colourless diamonds in a very classic design. The ruby of 5.123 ct (declared weight) is characterised by an attractive red colour and an outstanding purity, a combination rarely encountered in Burmese rubies of this size.

The small inclusions found by microscopic inspection and the analysed properties are consistent with those found in rubies from the classical ruby mines in the Mogok valley in Burma (Myanmar), well known for its wealth in gems since historic times. The attractive red colour of this ruby is due to a combination of well-balanced trace elements, which are characteristic of the finest rubies from Mogok.

In addition to these qualities, this ruby has been spared exposure to heat treatment and its clarity and colour are thus entirely natural.

A natural ruby from Burma of this size and quality can be considered rare and exceptional.
